

## OPMOD Limited Lifetime Warranty

OPMOD products (excluding night vision) are warranted by OpticsPlanet, Inc. to be free from defects in material and workmanship for the lifetime of the product. If your OPMOD product is found to have defects in material and workmanship, OpticsPlanet, Inc., at its option, will replace or repair the product, or provide a product of equal or greater replacement value free of charge.

Normal wear and tear or damage resulting from use, misuse, abuse, alterations, abnormal use, shipping damage, accident, loss, or theft are excluded from this warranty. Any defects or damage caused by service or repair performed by unauthorized persons or with unauthorized parts are excluded from this warranty. Warranty is non-transferrable and applies only to the original purchaser.

This warranty is in addition to and supplements any original manufacturer warranty that may exist on your OPMOD product.

All products must be pre-approved and a Return Merchandise Authorization (RMA) issued from OpticsPlanet, Inc. prior to return for warranty purposes. Shipping, postage, transportation, insurance, duties, taxes, and delivery are your responsibility.
